#### Foot Notes to Operating Budget:

- (1) August, 2005 cash balance, adjusted for projected expenditures to year end. This includes balance due on 2005 weed harvesting contract, towing charge, notice of meeting publication expense, etc.
- (2) The proposed Tax Levy for 2006 results in an assessment per property owner of \$69.26. This compares as follows.

2006	\$69.26
2005	\$80.82
2004	\$80.60
2003	\$52.22
2002	\$77.07
2001	\$75.22

- (3) Actual cost of 2005 contract adjusted for fuel cost increase.
- (4) In 2005 we began reserving for aerial spraying of Gypsy moths. The spraying done in 2004 will be effective for 4-6 more years. By allocating this reserve each year, the fund will be available when needed, while spreading our cost.
- (5) The fall picnic is self-sustaining, and we now have a comfortable reserve that can be used for unanticipated expenditures.
- (6) The last fish planting was done in 2003. Though we budgeted \$500 in 2004 and 2005, the committee did not use those funds. Thus, a decision was made by the officers to establish a reserve. The current plan is to wait until the results of fish shocking by the DNR, currently planned for early September. Then a longer range plan will be developed and implemented.
- (7) Membership in the Wisconsin Association of Lakes.
- (8) Cost of newspaper publication of notice of Meetings, a requirement of Chapter 33 of Wisconsin Statutes.
- (9) The insurance contract was re-bid in 2005, resulting in significant savings. The budgeted amount is left unchanged due to uncertainty of premium, upon renewal.

## **UP NORTH FRIENDS & NEIGHBORS**

- Please keep the speed limit on our Lake roads. There are many people walking, biking, jogging in the area anticipate their presence by maintaining a slow, reasonable speed as you drive.
- Please "drive to the right" keep to the far right hand side of the roads. With increased traffic, you
  probably will meet someone on the road anticipate that, too!

- If you are a jogger or walker always walk **facing** the traffic.
- Please drive ATVs alongside the road (NOT ON the road) slowly and with caution. Please, teach your children to drive the machine defensively, too.

- Remember your life jackets; make sure the children are wearing theirs.
- If you have a dog, keep it in your yard when you come to stay. Many residents and family members enjoy biking, jogging and walking around our beautiful lake. To be met or chased by a barking dog is VERY FRIGHTENING. No one should feel frightened while they relax and exercise here.
