**- September 1, 2012 -**

**Beecher Town Hall**

**- Call to Order -**

Call to order by Nancy McKenney.

Board of Commissioners in attendance: Nancy McKenney (via conference call), Phil Sweet (via conference call), Tracy Kupsh, John Keeley - Town of Beecher Representative, and Clancy Whiting - Marinette County.

Also in attendance, 32 Lake District members as well as Chuck Druckrey, Marinette County Water Resource Specialist and Shirley Prudhomme, Peshtigo Times Reporter.

**- Approval of Agenda -**

A motion was made by Clancy Whiting and seconded by Marcia Miracle to approve the agenda.

**- Reading of Minutes -**

A motion was to dispense with the reading of the minutes as they were printed in the annual newsletter. John Keeley asked to amend the 2011 annual meeting minutes as printed in the annual newsletter to strike the second sentence of the 5th paragraph, "... there are no reserve funds, as any excess funds were needed for the new town hall." Amended minutes were unanimously accepted.

**- Officers Reports -**

a) *Chairman Report*

b) *Treasurer Report*

Tracy Kupsh summarized the treasurers report is printed in the newsletter and reviewed the 2013 proposed budget.

c) *Town of Beecher Report*

John Keeley reported that the boat landing and dam was finished. It was noted that no motorized vehicles should be driven on the dock. Question was raised regarding how much the boat landing costs.

d) *Marinette County Report*

Clancy Whiting suggested land owners should attend a meeting on September 17, 2012 at the Dunbar Town Hall on proposed Marinette County Regulations Chapter 21 Shoreline Water Run-off. See the Marinette County website for more information.

e) *Aquatic Plan Committee Report*

Committee shared that the siphon drawdown technique dropped the lake level by 4.5 feet. Siphons worked better than expected and could have hit the 6 foot drawdown goal except for elevated areas in the channel area in front of the Schmeisser's property. Lake levels returned to original by March 20th despite low precipitation totals. The committee is exploring options to attain six foot goal in the future through dredging or other options. Plan to petition WDNR in an attempt to amend the grant to include dredging in lieu of chemical treatment costs. It was stated that no chemical treatment was performed in 2012 in order to comply with the terms of grant and determine the impact of the drawdown on EWM in areas where applicable. Marinette County mapped 11.5 acres of Eurasian Milfoil which they recommend treating. Grant will cover 75% of chemical treatment. The district will need to apply for an extension of the grant into 2013.

Howard Ritchie motioned to chemically treat the Lake in 2013, the motion was seconded by Fritz Schmeisser. Motion was passed.

f) *Communication Committee Report*

Doyle Curtis discussed the need to exchange information in a more timely manner. See the start of the website at beecherandupperlake.com. Doyle Curtis and Jim Prentiss are looking for committee members.

g) *Nomination Committee*

Nancy McKenney reviewed the election process. Tracy Kupsh nominated Judy Siudzinski for the open Board of Commissioner position.

**- Unfinished Business -**

a) *Easement on Warner Property*

The Board of Commissioners still plans to pursue a legal agreement allowing the Lake District to utilize the Warner Property for official Lake District business.

b) *Beecher Lake Insurance*

The Board of Commissioners is looking at options to add errors and omission coverage.

c) *Shoreline Protection Committee*

The Board of Commissioners is communicating the need for committee members and a chairperson.

d) *Ad hoc Boundaries Committee*

The Board of Commissioners is communicating the need for committee members and a chairperson.

**- New Business -**

a) *The 2013 budget was reviewed and the number of Lake District members was discussed.* A review of the Lake District properties with Marinette County and Carolyn Keeley - Town of Beecher Treasurer showed 71 properties within the boundaries. There was an increase in the number of Lake District properties as lots were subdivided. Marcia Miracle motioned to accept the proposed budget, the motion was seconded by Jim Lauscher.

The motion was passed unanimously.

b) *Board of Commissioners Election*

Tracy Kupsh motioned to elect Judy Siudzinski for the open Board of Commissioners position and the motion was seconded by Clancy Whiting. Motion passed unanimously.

**- Announcements -**

a) *The next Board of Commissioners meeting will be on November 10, 2012 at Beecher Town Hall*

b) *There was no picnic in 2012.*

**- Open Forum – Comments from Property Owners -**

1. Discussion was held regarding floating bogs on the lake. It was recommended that The District study removal strategies.

3. Paul Lassee questioned how the Lake District boundaries, specifically the 'Murray' property that was part of the original lake district boundaries and the lots, have been divided over the years. The District is looking for Boundaries Committee to review.

# Message from the Chair 2013

## Dear District Property Owner:

On behalf of the Beecher and Upper Lakes Public Inland Lake Protection and Rehabilitation District Board of Commissioners thank you for supporting and guiding us at the last year's 2013 Annual meeting. The Annual meeting directed the work of the District Board of Commissioners and Committees throughout the year.

As District property owners the Annual Meeting provides you with an opportunity to weigh in and advance important issues, provide guidance, vote on the budget, and elect new Commissioners. Please plan to attend the Annual District meeting on August 31, 2013, at the Beecher Town Hall from 9:00 am – Noon.

To carry out the day to day operations of the District, there are five commissioners: John Keeley, Supervisor, Town of Beecher and Clancy Whiting, Marinette County Board representative; Beecher Lake District property owners: Tracy Kupsh, Treasurer, who is completing the 2nd year of a 3-year term; Judy Siudzinski, Secretary, who is completing her 1st year of 3-year term and me, completing the 3rd year of my second 3-year term.

The Board of Commissioners has convened quarterly during 2012 and 2013 to monitor and manage the budget, consider changes to insurance, support committees, consider a long term solution to control of Eurasian Milfoil., and prepare for the Annual Meeting. Highlights from the Board of Commissioners and Committees include the following actions: 1) contributed \$400.00 to the Town of Beecher for the Beecher Lake boat landing improvements and new dock; 2) approved a new Boundaries Committee (members, charge, and budget); 3) reviewed and updated the insurance policies; and 4) submitted an Aquatic Invasive Species grant application.

This year the Aquatic Plant Committee, led by Joe Siudzinski, worked in cooperation with Chuck Druckrey, CLM, Marinette County Water Resource Specialist, to initiate and monitor the effects of a low dose whole lake chemical treatment. As you may recall our attempt to draw down lake levels to freeze out the Eurasian Milfoil (EWM) was met with limited success. This was due to several factors including extensive muck and debris that prohibited the flow of water from the main lake to the dam.

After further consideration, the District Board of Commissioners and Aquatic Plant Committee, in consultation with Chuck Druckrey, prepared an Aquatic Invasive Species grant application to the Wisconsin Department of Natural Resources. This application proposes multiple strategies for the effective, long-term control of Eurasian Milfoil.

Chuck Druckrey and Joe Siudzinski will be attending the August 31, 2013 Annual meeting Open Forum at 9:00 am to provide you with an evaluation of Eurasian Milfoil in the Lake, discuss the grant application, and answer your questions so that are prepared to vote on a resolution for **Requesting Wisconsin Aquatic Invasive Species Control Grant Funds** (see insert). To move forward, a majority of a quorum of the District must pass the resolution.

The goals of the application are to: 1) make the necessary changes to effectively use winter drawdown as a Eurasian Milfoil management tool, 2) minimize dependence on herbicides to control this invasive species, and 3) implement long term, effective controls in a cost effective manner.

The application proposes to:

- Modify the dam by installing a drain pipe and shut-off valve to:
  - Speed up water level changes.
  - Simplify the drawdown process.
  - Allow the drawdown to be maintained through winter.
- Dredge a channel from the main lake to the dam to:
  - Drain another 2.5 feet of water from Beecher and Upper Lakes.
- Selectively use herbicides and county-owned hydraulic harvester on isolated plants.
- Complete annual surveys to evaluate the effectiveness of management practices.

The total estimated cost of this project is \$175,735.00 over a 3 year period.

- The grant will fund (75%).
- The District share is estimated to be (25%).
- District reserve funds are currently available for this project.

With your approval we will continue advancing the grant application and if funded, implement the plan. Additional information is detailed in this newsletter. We are looking for property owner input at the Open Forum as we deliberate Eurasian Milfoil control measures. The Board of Commissioners supports long-term controls so that we can concentrate on other topics of interest to the Lake District.

The Shoreline Protection Committee (to monitor and address invasive plants and insects, including gypsy moths) and the Habitat/Fish Committee were authorized during the 2012 Annual Meeting. Please contact me or other Board of Commissioners if you are interested in leading the development of these committees (recruiting members, developing a charge or purpose, and a budget).

Thank you to all of the dedicated members of the Board of Commissioners and Committees. The District continues to benefit from resources provided by the Town of Beecher, Wisconsin Department of Natural Resources (DNR), and Marinette County. Beecher Township meetings are the second Tuesday of each month at 6:00 pm. Please let any Board of Commissioner know if you would be willing to attend the meetings.

Thank you once again, Helen and Doyle Curtis, for publishing the annual newsletter (Beach Chair News). It is a pleasure to serve the District with so many dedicated individuals.

If you have a desire to join a Committee or serve as a Board of Commissioner, please contact any of the Board Commissioners or Committee members.

### **Who makes up the Board of Commissioners?**

The Board of Commissioners is made up of five individuals. Three Commissioners are elected by property owners at the District Annual Meeting and serve 3-year staggered terms (all must be property owners and if possible, one a full-time resident). One representative is from the Town of Beecher Board, and one representative from the Marinette County Board.

### **How are the officers (Chair, Secretary, and Treasurer) determined?**

After elections at the Annual Meeting, the Board of Commissioners meets to determine who will assume the District Chair, Secretary, and Treasurer roles. Commissioners with experience in certain roles may wish to contribute to the District by applying their expertise (example: someone with accounting

experience may be the Treasurer). However, no specific occupational experience is required to be a Board of Commissioner.

### **What does the Board of Commissioners do for the District?**

Commissioners meet quarterly to carry out day to day District business with direction provided by property owners during the Annual meeting. The Chair presides at the annual meeting, at all special meetings and meetings of the Board, and at all public hearings held by the Board. The Secretary keeps minutes of all meetings, prepares and sends notices for all meetings. The treasurer is responsible for maintaining district funds, preparing reports, preparing an annual budget, preparing documents for Audit Committee review and certifying tax statements annually to present to the Town of Beecher Treasurer and Clerk.

Roles and duties are carried out in accordance with Wisconsin Statutes Chapter 19 General Duties of Public Officials (includes Open Meetings and Public Records), and Chapter 33 Public Inland Waters.

## Aquatic Plant Committee Committee Report to Board of Commissioners

### **Eurasian Milfoil Chemical Treatment for Beecher and Upper Lakes, 2013**

The effort stated in January where Brenda Nordin, WDNR Water Resource Specialist and Chuck Druckrey, Marinette County Water Resource Specialist met with the Board and Aquatic Committee at the Beecher Town Hall to understand the WDNR's proposal to switch to Whole Lake Chemical Treatment vs. Spot Treatments which we have completed in the past. Whole Lake Treatment entails distributing 2, 4-D liquid chemical, amount determine to be appropriate was 77 lbs. within the lakes in a manner whereby all water is treated. The chemical needs to be remain in contact with the plants for 14 days to be effective and the lakes needed to be stratified, weather warms enough in Spring that the least dense water masses sit above the more dense layers allowing chemicals to float across the more dense layers and impact the shallow areas where the vegetation is available for treatment. The outcome of this January meeting was consensus to migrate to Whole Lake Treatment and start planning for the new requirements that were needed for whole treatment.

Sampling requirements prior to the treatment included temperature profiling to determine stratification and water lever monitoring to determine the total number of gallons within the lakes and the water outflow.

Treatment occurred on May 17th of this year, and we began executing the sampling and temperature requirements of the chemical treatment permit the next day. Overall, we sampled the lakes to determine chemical levels based on the WDNR's Plan on 10 different field visits with 11 sampling points each time along with a temperature profile at a keystone point and temperature at each sampling point. The purpose of the sampling is to determine how quickly the chemicals break down based upon a variety of factors, lake characteristic, water temps, tannins, water currents and weather based; storm events during and after treatments, ambient air temperatures, etc. The samples were then sent to Florida to be analyzed by the Corp. of Engineers for inclusion into a national database of testing results. This was completed at no additional expense to the Lake District or the WDNR.

On July 18th, Chuck and a Marinette County intern along with Brenda and two additional WDNR employees spent an entire day on the lakes in 2 boats in 90 degree hot summer weather analyzing sample points on both lakes for milfoil and profiling other vegetation within the lakes. We should have some of those results and data points to share at the annual meeting.

Observations from the results are encouraging and discouraging at the same time. Milfoil is present in the lakes; we did not expect anything less. Many areas where we had dense coverage and colonies have not formed as in the past. Other areas where we have had good control with spot (pellet form) chemical treatments on the North shores of Upper Lake and the channel, treatment has not been very effective. Our thoughts is the water inflow from Beecher Creek followed the shore around and the chemical washed to other areas of the lakes due to the currents in those areas. We may have to modify our treatment type in the future in those areas. There will be more to follow on the effectiveness of the treatment and alternatives at the annual meeting, please plan on attending.

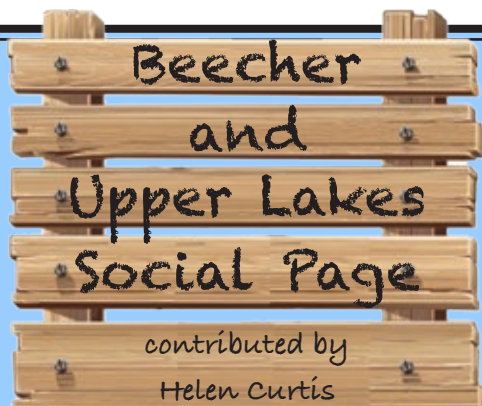

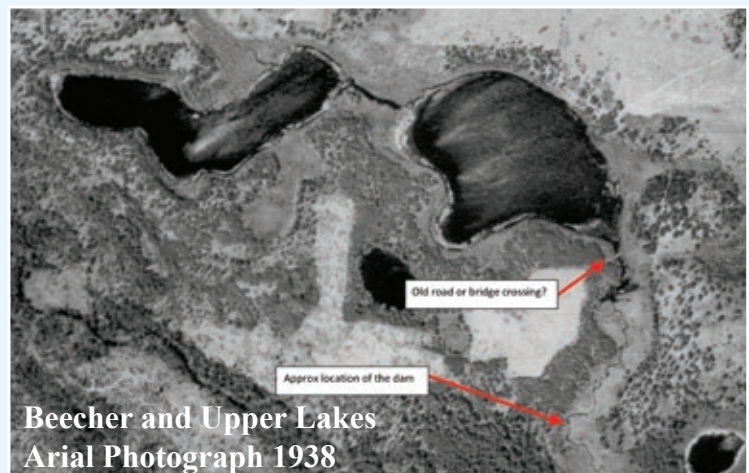
