Annual Meeting

- August 31, 2013 -Beecher Town Hall Beecher, Wisconsin

- Open Forum-

Joe Siudzinski reviewed the history of the milfoil

- o First identified in 2007
- WDNR suggested chemical treatment; applied for first grant; agreed to chemical treat; no grant share at time, spent \$15,000; raised District fee in 2009
- Then applied for Chemical treatment grant allowed 2nd treatment in 2010
- Learned from first treatment applications and began to change timeframe of treatment
- In 2011, built Lake siphons and attempted Lake draw down
- o Proved Lake draw down could occur and Lake would fill back up
- Not successful in milfoil reduction because of the weather that year and the ability to get Lake to low enough water level
- Approached County and Board on dredging issue;
 applied for grant variance allowing dredging as part of funded solution
- 2013 performed whole Lake treatment and had some issues with water flow (based on recently dug out area by the boat landing) that negatively impacted the treat ment results in some areas; plan to look for input from County moving forward
- Chuck Druckrey then shared the proposed timeline for the EWM Control Project (Phase II) – Dam Modifications and Dredging (document provided to meeting participants)
- Open discussion by the group concerning various specifics about the project
- Nancy explained the need for a quorum of 36 property owner votes, and the need for 18 to vote "yes"

- Agenda Amendment -

Nancy McKenney made a motion to amend the agenda allowing the meeting to remain open until 3pm on August 31, 2013 for the purpose of conducting the ballot for consideration of the Aquatic Plant Dredging Grant Application. Tracy Kupsh moved to approve the motion, Marcia Miracle seconded — all in favor; no opposed.

- Reading of Minutes -

Nancy McKenney made a motion to approve the minutes as written in the Beach Chair News. Fritz Schmeisser moved to approve the motion, Gene Wickman seconded. The minutes were not read as agreed by meeting participants.

- Commissioner Reports -

Chairperson:

Nancy McKenney covered the following:

- officially recognized the Beecher Township for the improvements in the Beecher boat landing
- acknowledged that John Keeley and Bob Gehri worked well together with Chuck Druckrey and Joe Siudzinski in the Lake milfoil eradication
- thanked Clancy Whiting for his leadership
- shared an update on the approval of a Boundary committee and shared that a Shoreline and Fish Habitat committee

- had not been formed because of lack of volunteers
- asked anyone interested in any of the committees to contact Tracy Kupsh or Judy Siudzinski
- recognized Board Members, Aquatic Plant Committee, and Chuck Druckrey for his work in the grant application
- · mentioned the work-in-progress on updating insurance
- recognized Helen Hohl and Doyle Curtis for the excellent work on the newsletter

Secretary Report:

Judy Siudzinski, Secretary, represented nothing to report.

Treasurer's Report:

Reviewed 2013 Budget as of July, 2013; reported 2012 start at \$30,596.07, after income expenses, July 2013 year-end balance of \$31,019.49

Beecher Township:

Beecher Town Supervisor, John Keeley reported that he successfully positioned the signs at the boat landing as committed in previous discussions.

Marinette County Representative, Clancy Whiting, attended recent update from the WDNR on the Impervious Surface Rules. Aim of original rules was to improve water quality by managing run off from hard surfaces. The rules regulate building of new structures and are implemented and policed through permitting processes. Changes were made to the originally established rules because of public acceptance issues. Initial rules were to be effective February, 2014, unclear when regulations will now go into effect.

- Committee Reports -

Aquatic Plant Committee:

See early open forum discussion notes.

Boundary Committee:

Bob Magnuson represented the update, sharing that the group had met a couple of times. It was noted that there was nothing pressing for this committee right now. Bob Magnuson referenced that the Committee had been formed in response to recent requests for property detachment from the District. At some time, the Committee may further review boundaries, but right now there is no intent to do that.

Nominations Committee:

Nancy McKenney shared that her term would conclude at the end of this year's Annual Meeting and that there had been no nominations received.

- Unfinished Business -

Shoreline Committee: Nancy McKenney mentioned that if the Lake wants a Shoreline Committee, a group needs to come forward and develop a charge. Marcia Miracle agreed to work to get committee started and mentioned concern about Oak Wilt and how it is spread. Marcia Miracle referenced a book from the UW Extension that provides education on behaviors that drive good and bad outcomes to Lake.

Fish Habitat Committee: Nancy McKenney reiterated that this committee had not been formed because of lack of volunteers. She suggested that any interest for volunteers be communicated to a Board of Commissioners.

It was reiterated that the meeting would remain in session until 3pm for the purpose of voting for the Aquatic Plant and Dredging Application. It was also repeated that there was one vote per property.

Annual Meeting (continued)

2014 Budget:

Tracy Kupsh reviewed the budget comparing proposed 2014 numbers to 2013. The information outlined transfers between areas and referenced an aim to increase monies for the Aquatic Plant Committee. The end result was a proposed increase of roughly \$7 to \$8 per property for the 2014 tax rate. Glen Schilling motioned to accept the proposed tax rate, Rick Scray seconded. There was no discussion and all were in favor, no opposed.

Board of Commissioners Election:

Nancy McKenney asked for interest in joining Board of Commissioners to fill the pending vacancy. She explained specific Board role assignment (Secretary, Treasurer, Chair), and she clarified that role assignment was flexible and established once elected party was in office. Nominations were called from the floor three (3) times.

Tracy Kupsh nominated Nancy McKenney for the Board of Commissioners. Nancy McKenney accepted. Tracy Kupsh moved, and Judy Siudzinski seconded that Nancy McKenney accept the nomination. Nancy McKenney accepted.

Last Order of Business:

Fritz Schmeisser moved that from this day forward, the Lake District issue a good friend and neighbor award and further that it be called the 'Friends are Devine Award', Jim Johnson seconded the motion. It was agreed this would be an annual award. Nancy McKenney adjourned to recess – as meeting stayed open until 3pm.

Additional votes were received and recorded between recess and 3pm meeting adjournment.

At the close of meeting, there were 37 votes documented, all were in favor.

Nancy McKenney, accompanied by the other 2 Board of Commissioners, adjourned the Annual meeting at 3PM.




Every other Wednesday in Amberg, food is distributed to those in need.

Beecher and Upper Lakes Protection and Rehabilitation District Board of Commissioner

Tracy Kupsh is completing the last year of her second threeyear term. We are grateful for her dedication and willingness to serve.

Are you or someone you know interested in serving as a Board of Commissioner for the District?

Who makes up the Board of Commissioners?

The Board of Commissioners is made up of five individuals. Three Commissioners are elected by property owners at the District Annual Meeting and serve 3-year staggered terms (all must be property owners and if possible, one a full-time resident). One representative is from the Town of Beecher Board, and one representative from the Marinette County Board.

How are the officers (Chair, Secretary, and Treasurer) determined?

After elections at the Annual Meeting, the Board of Commissioners meets to determine who will assume the District Chair, Secretary, and Treasurer roles. Commissioners with experience in certain roles may wish to contribute to the District by applying their expertise (example: someone with accounting experience may be the Treasurer). However, no specific occu-

pational experience is required to be a Board of Commissioner.

What does the Board of Commissioners do for the District? Commissioners meet quarterly to carry out day to day District business with direction provided by property owners during the Annual meeting. The Chair presides at the annual meeting, at all special meetings and meetings of the Board, and at all public hearings held by the Board. The Secretary keeps minutes of all meetings, prepares and sends notices for all meetings. The treasurer is responsible for maintaining district funds, preparing reports, preparing an annual budget, preparing documents for Audit Committee review and certifying tax statements annually

Roles and duties are carried out in accordance with Wisconsin Statutes Chapter 19 General Duties of Public Officials (includes Open Meetings and Public Records), and Chapter 33 Public Inland Waters.

Aquatic Plant Committee Committee Report to Board of Commissioners

Committee Members: Doyle Curtis, Mike Gotstein, Joe Siudzinski

Greetings Lake District Stakeholders:

2014 was a year of change and year of running in place all at the same time.

Our dredging grant was submitted August of 2013 and again in February of 2014 and was outscored by competing applicants and thus not funded. Our path forward is to ask for your approval to co-fund the grant up to 50% during a Open Forum that will start prior to the annual meeting. 50% co-share is the last remaining option to add points under the scoring system used to evaluate grant applications. The grant application would be submitted in February of 2015 with the execution in Fall of 2015 and Winter of 2016, weather and schedule dependent. All permits and permissions needed have been procured and completed for the dredging project.

We would really appreciate your input and attendance at this Open Forum. Brenda Nordin of the WDNR and Chuck Druckrey of Marinette County will be attending and presenting at 9AM. You will have the opportunity to learn about the Eurasian milfoil methodology that has been used, sampling program, results of the chemical treatment that occurred in 2013 and 2014 as well as a review of the dredging grant application. Your questions and suggestions are welcome.

Special thanks to Chuck and Marinette County for helping us with a portion of the cost of the 2014 chemical treatment and both Brenda and Chuck for their expertise and efforts to help us make the treatment application as successful as it could be. We will not be chemically treating in 2015, three successive years of chemical treatment does not make sense from both an environmentally and financially point of view. As you may surmised, this makes the success of our dredging grant application all the more critical. Thank you in advance for your attendance and participation in this important crossroad for Beecher and Upper Lakes.

Message from the Chair 2014

Dear District Property Owner:

On behalf of the Beecher and Upper Lakes Public Inland Lake Protection and Rehabilitation District Board of Commissioners thank you for supporting and guiding us at the last year's 2014 Annual meeting. The District Board of Commissioners and Committees worked hard to carry out your directives

As District property owners the Annual Meeting provides you with an opportunity to weigh in and advance important issues, provide guidance, vote on the budget, and elect new Commissioners. Please plan to attend the Annual District meeting on August 30, 2014, at the Beecher Town Hall from 9:00

To carry out the day to day operations of the District, there are five commissioners: John Keeley, Supervisor, Town of Beecher, Clancy Whiting and Marinette County Board representative; Beecher Lake District property owners: Tracy Kupsh, Treasurer, who is completing her 3rd year of a 3-year term, Judy Siudzinski, Secretary, who is completing her 2nd year of 3-year term and me, completing the 1st year of my third 3-year term.

The Board of Commissioners has convened quarterly during 2013 and 2014 to monitor and manage the budget, insurance, support committees, work toward a long term solution to control Eurasian Milfoil, and prepare for the Annual Meeting. As you may recall our attempt to draw down lake levels to freeze out the Eurasian Milfoil (EWM) was met with limited success. This was due to several factors including extensive muck and debris that prohibited the flow of water from the main lake to the dam. Highlights from the 2013-2014 Board of Commissioners and Committees included: 1) Receiving approval from the Army Corp of Engineers to dredge the channel leading to the dam, effective through 2016 (to enable a successful draw down)

Submitting an Aquatic Invasive Species grant application to the Wisconsin DNR (although not funded).

3) In lieu of a draw down, initiating a low dose whole-lake chemical treatment and monitoring the effectiveness.

We have been encouraged to reapply for the grant. To be successful with our application, the Board of Commissioners is proposing to increase the District match from 25% to 50%. Increasing the District match would result in additional grant scoring points. Of the 50% District match, in-kind (equipment and sweat equity) could be used toward the match, we would request funds from Marinette County, and the remaining match would come from the District funds. We have reserve funds, but would need to borrow funds under this scenario.

Chuck Druckrey, CLM Marinette County, Brenda Nordin, WI DNR, and Joe Siudzinski, Chair, Aquatic Plant Committee will be attending the August 30, 2014 Annual meeting Open Forum at 9:00 am to provide you with an evaluation of Eurasian Milfoil in the Lake, discuss a new grant application, and answer your questions so that you are prepared to vote on a resolution for Requesting Wisconsin Aquatic Invasive Species Control Grant Funds (see insert). To move forward, a majority of property owners in attendance must pass the resolution.

The goals of the application are to: 1) make the necessary changes to effectively use winter drawdown as a Eurasian Milfoil management tool, 2) minimize dependence on herbicides to control this invasive species, and 3) implement long term, effective controls in a cost effective manner.

The application proposes to:

- Modify the dam by installing a drain pipe and shut-off valve to:
 - Speed up water level changes.
 - Simplify the draw down process. 0
 - o Allow the draw down to be maintained through winter.
- Dredge a channel from the main lake to the dam to:
 - o Drain another 2.5 feet of water from Beecher and Upper Lakes.
- Selectively use herbicides and county-owned hydraulic harvester on isolated plants.
- Complete annual surveys to evaluate the effectiveness of management practices.

The total estimated cost of this project is \$180,735.00 over a 3 year period. The 2014 proposal is that:

• The grant funds an estimated \$90,367 (50%).

- The District matches an estimated \$90,367 (50%).
- Of the 50% District match approximately:
 - \$ 1,808 (2%) would be in-kind contribution (sweat equity and equipment)
 - \$ 9,037 (10%) would be requested from Marinette County \$79,522 (88%) would be District funds
- Upfront borrowing of funds will be required to cover costs.

The resolution will: 1) authorize the application, 2) consider the change in match, and 3) approve borrowing of funds to help costs. With your approval we will continue advancing the grant application and if funded, implement the plan. Additional information is detailed in this newsletter. We hope to have good discussions at the Open Forum as we deliberate Eurasian Milfoil control measures. The Board of Commissioners supports long-term controls so that we can concentrate on other topics of interest to the Lake District.

The Shoreline Protection Committee (monitor and address invasive plants and insects, including gypsy moths) and Habitat/Fish Committee were authorized during the 2012 Annual Meeting. Please contact me or other Board of Commissioners if you are interested in leading the development of these committees (recruiting members, developing a charge or purpose, and a budget).

The District has many dedicated members on the Board of Commissioners and Committees. We continue to benefit from resources provided by the Town of Beecher, Wisconsin Department of Natural Resources (DNR), and Marinette County. Beecher Township meetings are the second Tuesday of each month at 6:00 pm. Please let any Board of Commissioner know if you would be willing to attend the meetings.

Thank you, Helen and Doyle Curtis, for publishing the annual newsletter (Beach Chair News). It is a pleasure to serve along these dedicated individuals.

We are seeking nominations for the "Good Friends are Devine Award" this year. If you have a nominee, please contact one of the Board of Commissioners prior to August 25, 2014. If you have a desire to join a Committee or serve as a Board of Commissioner, please contact any of the Board Commissioners or Committee members.

The Board of Commissioners looks forward to seeing you on August 30, 2014.
