#### **Call to Order:**

Meeting was called to order by Nancy McKenney at 9:00 AM

# **Approval of Agenda:**

### **Approval of Minutes:**

#### **Commissioners Reports:**

Chairperson Report – Nancy McKenney stated that the dredging project was the only item she had to report. More information would be forthcoming when Joe Siudzinski gave his report from the Aquatic Plant Committee.

Secretary Report – Jim Johnson stated that he had no new business at this time.

Treasurers Report – Tracy Kupsh shared with the group the Jan. 2017 balance sheet (via email, Appendix 1). The report showed Current Funds on Hand to be \$68,878.03 which matches the current bank statement. Tracy stated that from a financial aspect, everything related to the dredging projects is progressing according to the Aquatic Committees original timeline.

Beecher Town Board Representative – John Keeley had nothing new to report from the Town of Beecher at this time.

*Marinette County Supervisor Representative -* Cary (Clancy) Whiting was not in attendance at this meeting.

#### **Committee Reports:**

Aquatic Plant Committee – Joe Siudzinski gave a written update (email) and attended the meeting to answer any questions the board had related to the dredging project. The current plan is to have another Drawdown in the Fall of 2017 to test the effectiveness of the new system, with subsequent selective chemical treatments in 2018. Hi Joe,

I was at the lake today and they have made it around the point. On Monday and Wednesday they made a lot of progress, hauling out nearly 100 loads each day. However, the unseasonably warm weather is starting to affect them. The "haul road" was cleared up to Kelly Phillips dock more than two weeks ago so there is good frost and its holding up nicely. From Phillips place north the ice and snow was only stripped last Saturday so there is not enough frost and they ran into a real mucky section in this area. This morning they got a dump truck stuck and nearly sank the backhoe. They also got the dozer buried in the dredge spoil pile! In general, everything is a muddy mess right now.

In talking to Bill Feck (the site manager) they will go as far as they can to the north today and them move back down to see if they can make any progress closer to the dam. They started the dredging about 100 feet from the dam and stripped off the ice closer to the dam in hopes that cold weather would firm things up in that area... obviously it hasn't but they wanted to give it a shot.

Tomorrow may be the last day on site until we get some colder weather. The daily highs are projected to stay near 40 until next Saturday so they might not be back until the following week. It's not ideal but they aren't making money if they are pulling equipment out of the mud all day.

Tomorrow they are also going to clear sow from the alternate disposal site in case they need it. With the warm weather they are having trouble stacking the dredge spoils so they are running out of room at Kupsh's property. I called Betty Hensel and let her know. she is fine with it.

Also, they are hauling out all the snow and ice piles as they work north. Right now there is still a lot of snow and ice piled up by McKenny's but that will be removed when they return to the area.

We erected barrier netting and caution tape out on the ice north of the bay and posted signs at the boat landing and beach.

We haven't heard any complaints for a while but the highway department stopped and told the contractor they needed to scrape the mud off of Highway L near the disposal site. They are bringing up a skid-steer to do that this afternoon. Tomorrow they plan on cleaning up Dam Road as well.
