Aquatic Plant Committee

- Submit all expenses to the Treasurer for payment

Committee Membership: The Aquatic Plant Committee will consist of at least three District property owners.

Audit Committee

Charge: The Audit Committee is appointed annually by the BOC to assist the Beecher Lake and Upper Lakes Inland Lake Protection and Rehabilitation District in monitoring:

- The integrity of the Lake District financial records
- The compliance by the BOC with any legal and regulatory financial requirements

Procedures:

- Financial records for the September to August fiscal year will be supplied by the Treasurer.
- The Audit Committee shall review the financial records of the Lake District for the fiscal year.
- The fiscal year audit will begin in September and must be completed prior to December 31st of that same year.
- During the audit period the committee may request more details from the BOC where necessary.

- The Treasurer must supply the Chairperson with a copy of the signed audit report.

Letter from the Chair-2022

The Lake District was formed more than 20 years ago, as a governmental tax district, to aid in the protection and rehabilitation of Beecher and Upper Lakes. As a tax district we have access to the resources of Marinette County and the state of Wisconsin. As Commissioners, we carry out the decisions you make at the Annual meeting. In past years, we were able to spray the entire lake shoreline for gypsy moths. Controlling Eurasian Milfoil has taken several years of draining the lake, chemical treatment and dam modification and appears be working. Through your district assessment dollars and state grants we have been able to work to keep Beecher and Upper Lakes a wonderful place to live and vacation.

The Board of Commissioners for the Lake are elected by the Lake District members (YOU) at our annual meeting on Labor Day weekend. I have completed my 1st year of my 2nd term. Amy Komis, who serves as Treasurer and is finishing her 2nd year of her first term. Jim Johnson is the Secretary and has completed his second 3 year term. The District has two additional commissioners: Dave Paulsen, supervisor from the Town of Beecher and Marinette County representative, Ken Hanson.

Thanks to the tireless efforts of Joe Siudzinski and the Aquatic Plant Committee, the 2nd valve was installed last fall. This allowed us to get the water levels low enough to freeze out the Milfoil, which thrives closer to the shore. Marinette County will be completing the plant survey in the next few weeks to assess the success of the last draw down. Our goal is to significantly decrease the need to draw down the lake and rely on spot chemical treatment of the most troublesome spots.

While the Lake District has elected members and can access to county resources, it can't function without our many volunteers. We honor Paul LaSee who passed away since our last Annual Meeting. Paul was on the Fish Habitat Committee for a long time. Thank you to those who lead these committees and all the people who help them. Please consider offering your time and talent to our Lake. Everything these volunteers do adds to the value of **your** home or cottage on the lake. They are weary and could use help!! We can't thank them enough.

2022 Treasurer's Report September 2022 Submitted by Amy Komis, Treasurer

The Beecher and Upper Lakes Public Inland Lake Protection and Rehabilitation District (the district) began the fiscal year with a balance of \$58,795.91.

The annual audit was conducted by Glenn Schilling on August 17 and 18, 2021. All receipts and expenses were verified back to invoices, check copies, checkbook ledger and bank statements provided by Stephenson National Bank & Trust. No discrepancies or errors were found.

The major expenditure of the year was the dam project with came in at \$49,426.47 and \$563.53 under budget. (Ref: 512.50 paid in F2021 and \$48913.95 paid in F2022)

However, the audit did note a \$200 shortfall in the tax assessment.

Aquatic Plant Committee

From Chuck Druckrey: "I suspect that conducting a drawdown every three to four years will be typical. Of course, that assumes the drawdown is successful and you get a good sediment freeze to kill the EWM. The frequency will vary based on the speed of EWM recovery and people's tolerance for the plant. In the plan I listed a "trigger" for conducting a drawdown of finding EWM at 30% of the sample plots when we do aquatic plant surveys.

I plan on conducting annual aquatic plant surveys every summer for the next three or four years to track changes in the plant community after last winter's drawdown. I will schedule it for early august so I can report on the drawdown at the meeting on 09/03. I'll also try to get out on the lake earlier if possible, to have a look around. If any of the new APC want to meet and survey the lake let me know and I'll set something up.

As for maintenance of the drains, since they will only be operated sporadically, the DNR had recommended that the be opened every year for a few minutes to ensure smooth operation and to flush out sediment that might build up in the pipes while they are not being used."
